Dear Santa Fe Healthcare Center Patient,

This letter includes some very important changes regarding our ABQ Health Partners Santa Fe Health Care Center.

After careful review, the decision has been made by ABQ Health Partners to close our Santa Fe Healthcare Center at 465 St. Michaels Drive, Santa Fe, New Mexico effective August 6, 2010.

It is important to us that we assist you, our patients in transitioning to new Healthcare Providers. The closure of this Healthcare Center specific to the providers will take place in two stages.

YOUR DOCTOR:

1.) Dr. Julie Martinez and Dr. Patrick Samora:

- **Dr. Julie Martinez's and Dr. Patrick Samora's last day in our Healthcare Center will be on June 30, 2010.** You can continue to see these doctors through this date.
- At this time, a future practice site for these two physicians has not yet been determined. Feel free to contact our Healthcare Center at 505-995-2400 for any questions regarding their future practice site and we will share information as it is available to us.
- If you are a patient of Dr. Samora or Dr. Martinez, please select a new provider in the community before this date. You can do this by contacting your Health Plan's Member Services Department to establish with a new provider. Please refer to your Health Plan's Member Handbook or ID card for the phone number.

2.) Dr. Stephen Dunlap:

- **Dr. Stephen Dunlap's last day will be on August 5, 2010.** You can continue to see this doctor through this date.
- We are pleased to announce that Dr. Dunlap will be staying with ABQ Health Partners in Albuquerque, serving in a non-Primary Care role.
- If you are a patient of Dr. Dunlap, please select a new provider in the community before this date. You can do this by contacting your Health Plan's Member Services Department to establish with a new provider. Please refer to your Health Plan's Member Handbook or ID card for the phone number.

YOUR MEDICAL RECORDS:

You have two options to request your Medical Records:

- 1.) You can call toll free 1-800-877-7526, extension 27220 to request a transfer of your Medical Records and we will gladly send a copy to your new provider.
- 2.) You can complete the Release of Information form that is included with this letter and take it directly to our Santa Fe Healthcare Center location. This option is only available to you through August 6th.
